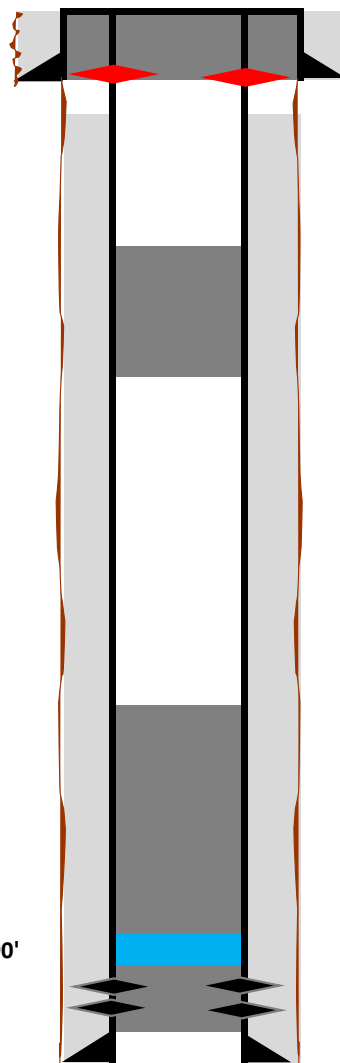

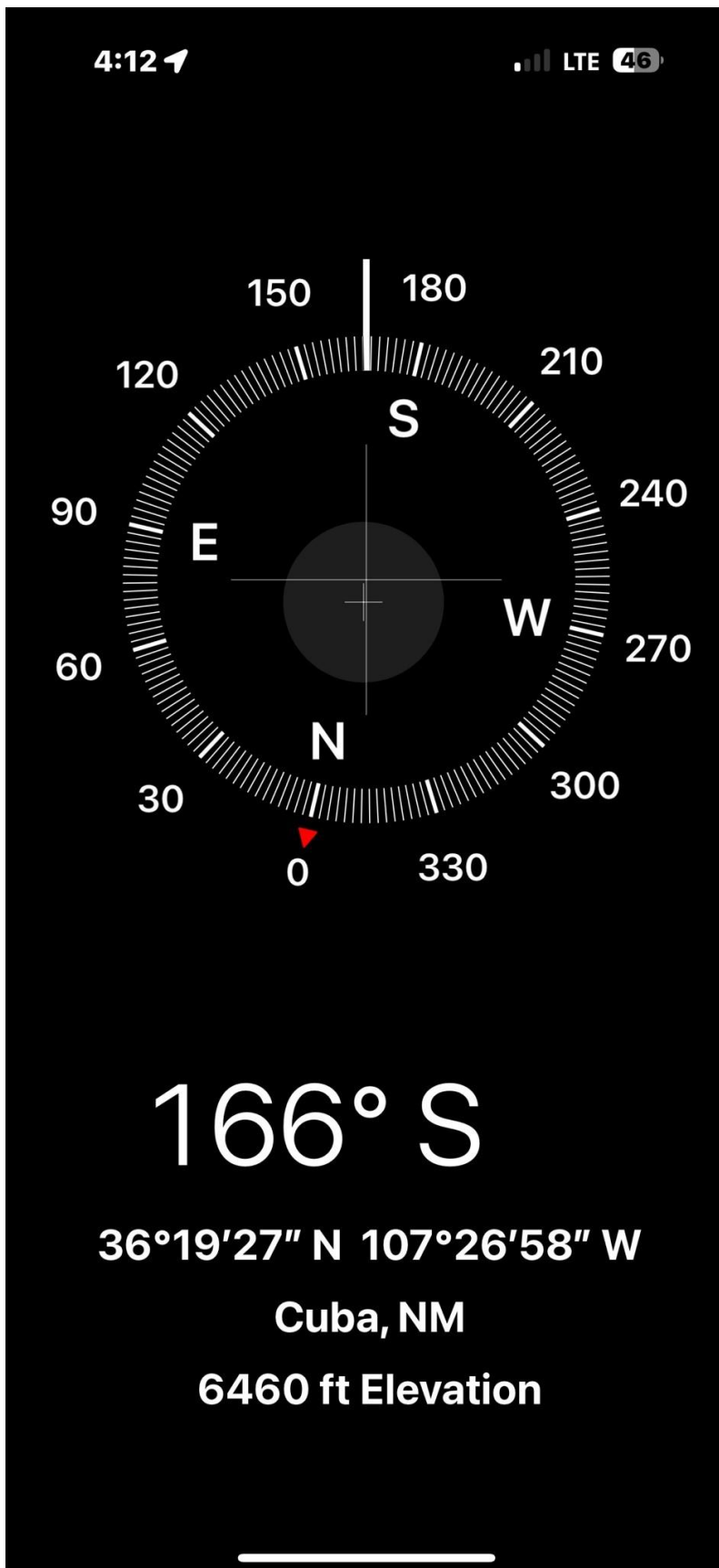


Figure 2: GPS
