Procedure Description: BLM Bond NMB001079 Surety Bond No.: RLB0015172 Matador Production Company respectfully requests that the Bureau of Land Management (“BLM”) approve the extensions of the Applications for Permits to Drill (“APD”) referenced herein. MPC received these APDs as part of its acquisition of Ameredev in 2024 and there are four horizontal wells currently producing on this unit. MPC is completing two Rae’s Creek wells nearby and scheduled to test a new zone in December 2025 and MRC believes it would be best practice to monitor the production from these future wells to inform how MPC should continue its development on the Pine Straw project. As a result, a 24-month extension is requested to prudently develop the remainder of the Pine Straw project and reduce waste.
