

Nov 30 - Dec 1/23 Permian 5 moved rig to location. BLM notified of plugging 12/1/23.

12/4/2023 NU BOP and dig out cellar. RIH w/ bit and scraper and 150 jts tubing, leave scrper hanging at 4738'. SDFN

12/5/2023 RIH to 8322' (261 jts.). Pump 25 sx class H plug. Pull up 2000' and WOC 4 hrs. RIH and tag at 7928'. POH w/ bit and scraper, LD 1322' of tubing. SDFN

12/6/2023 RIH w/ CIBP and set at 7008'. Load hole w/ 9.5# plug mud, 25 sx gell/100 bbls. and test casing 500 psi, Good. Spot 25 sx class H plug on top of CIBP. Pull up to 5572' and spot 25 sx class C plug. Pull up and WOC. RIH and tag @ 5444'. Pull 15 stands and SDFN

12/7/23 Pump 107 sx class C plug @ 4550. POH, RIH w/ packer and 6 jts tailpipe, tag @ 3480'. Pull up and RIH w/ wireline and perforate 3227'. Set packer @ 2688' and establish injection. 2.5 bpm @ 600 psi. RIH to 3480' and spot 30 sx class C cement. Pull up and set packer @ 2496 and tailpipe at 2688' and squeeze 575 sx cement to bring cement to surface in 5 1/2" X 8 5/8" annulus. Displace cement down tubing to 3100'. Shut well in for night.

12/8/23 Unset packer and tag plug @ 3033'. POH 1d packer, RIH to 3033. Pump 200 sx class c @ 3033'. WOC and Tag @ 985'. RIH to 985' and fill hole from surface to 985' w/ 100 sx class C cement.

12/13/23 Permian 5 dug out wellhead and cut off 8 5/8 and 5 1/2" casing. BLM approved cement to surface all strings.

12/14/23 Weld plate on casings and install below ground plug marker.




## Well Bore Diagram Worksheet
