Conditions of Approval for Final Extension of Temporary Abandonment of Wells

Pursuant to 43 CFR 3162.3-4.d.3 & e.3, no well may be non-productive for more than 4 consecutive years.

1. TA status will be approved for a period of up to one year from the date of sundry approval.
2. Within 9 months of the approval date of this sundry, the operator must submit one of the following:
 - a. A Workover Notice of Intent (NOI) sundry that includes the planned operations and expected date the well will be brought back into production -or-
 - b. A Plug and Abandonment NOI sundry that includes the planned operations and expected date to permanently abandon the well -or-
 - c. A Temporary Abandonment Subsequent Report sundry that includes a detailed plan and timeline for future beneficial use of the well. The sundry must include:
 - i. An explanation for why the well must remain temporarily abandoned (i.e. why can the well not be brought online today?)
 - ii. A timeline that includes:
 1. Verifiable progress markers (e.g “Construction of flowlines will begin by xx/xx/xxxx”)
 2. A date when the well will be brought online
