Southwest Royalties, Inc. is requesting a TA permit for the VM Henderson wells while we work to implement a long-term development plan. The offsetting Empire Eunice Monument Unit has produced nearly 44 MBO utilizing secondary recovery from the Grayburg formation. We believe similar potential exists in the VM Henderson lease, which currently produces marginal volumes from the Grayburg but has not been flooded. The VM Henderson #15 currently injects into the deeper San Andres formation and therefore provides no injection support to the Grayburg. SWR plans to recomplete the VM Henderson #15 in the Grayburg in Q4 2026 and produce select offsetting VM Henderson wells to evaluate potential injection support. If successful, a larger project would follow involving unitization, additional well conversions, and field-wide development over the next 1–2 years. If unsuccessful, SWR plans to P&A the wells in 2028.

Therefore, Operator has within a 30-day period from the M.I.T. to submit a current C-103 along with a legible scan of the Chart, including a detailed description of the repair(s). **Only after receipt of the C-103 will the non-compliance be closed.**

 M.I.T. is successful, Initial of an injection well, you must submit a **form C-103** to NMOCD within 30 days. A **C-103 form** must include a detailed description of the work performed on this well including the position of the packer, tubing Information, the date of first Injection, the tubing pressure and Injection volume.

Please ensure all documentation requirements are in place prior to injection process.




