

**Objective:** Run Production Log & Cement Squeeze perfs to shut-off high GOR production.


**Job Plan:**

1. Pull ESP equipment.
2. Run Production Log to confirm zones of high gas entry (Zn2C is suspected high gas zone).
3. Cement Sqz upper perfs (Zn2C) f/ 4202'-4240' w/ ~400 sx Class C cmt.
4. DO & Pressure Test Sqz x CO to 4459' PBTD.
5. Reperf & AT lower perforations f/ 4266' to 4376' as required.
6. Install ESP equipment.
7. Return well to production.
