It has produced since its initial completion. We are requesting to frac the perforations to stimulate production. No new perforations are to be made. The proposed procedure is below and we have attached the current and proposed WBD. 1. POOH with rods and production tbg. 2. RIH with work string and packer. Set packer at 4,600' 3. Frac Yeso perforations from 4,669'-4,990'. 4. POOH and RIH with production tubing, anchor, rods, & pump. 5. Put well back on production.

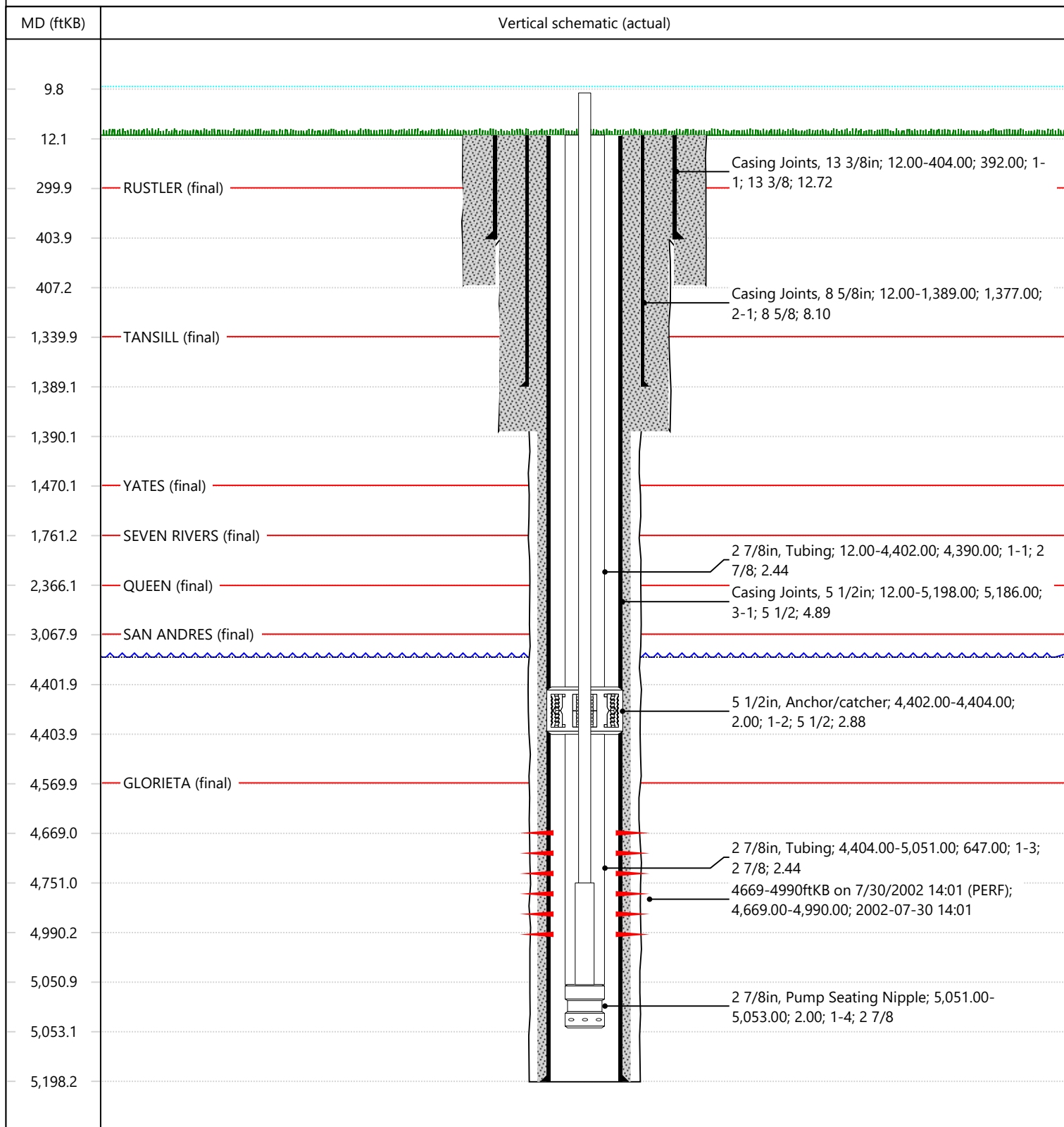
