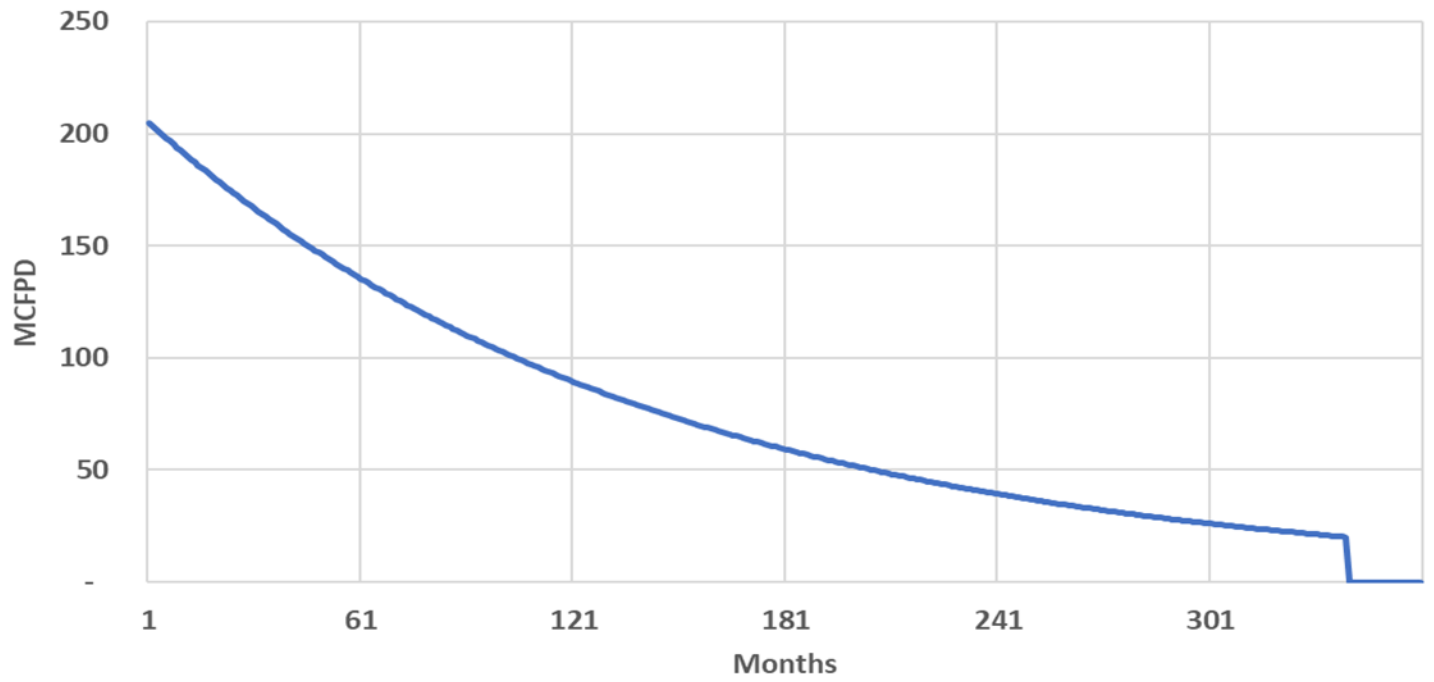

Pictured Cliffs Forecast

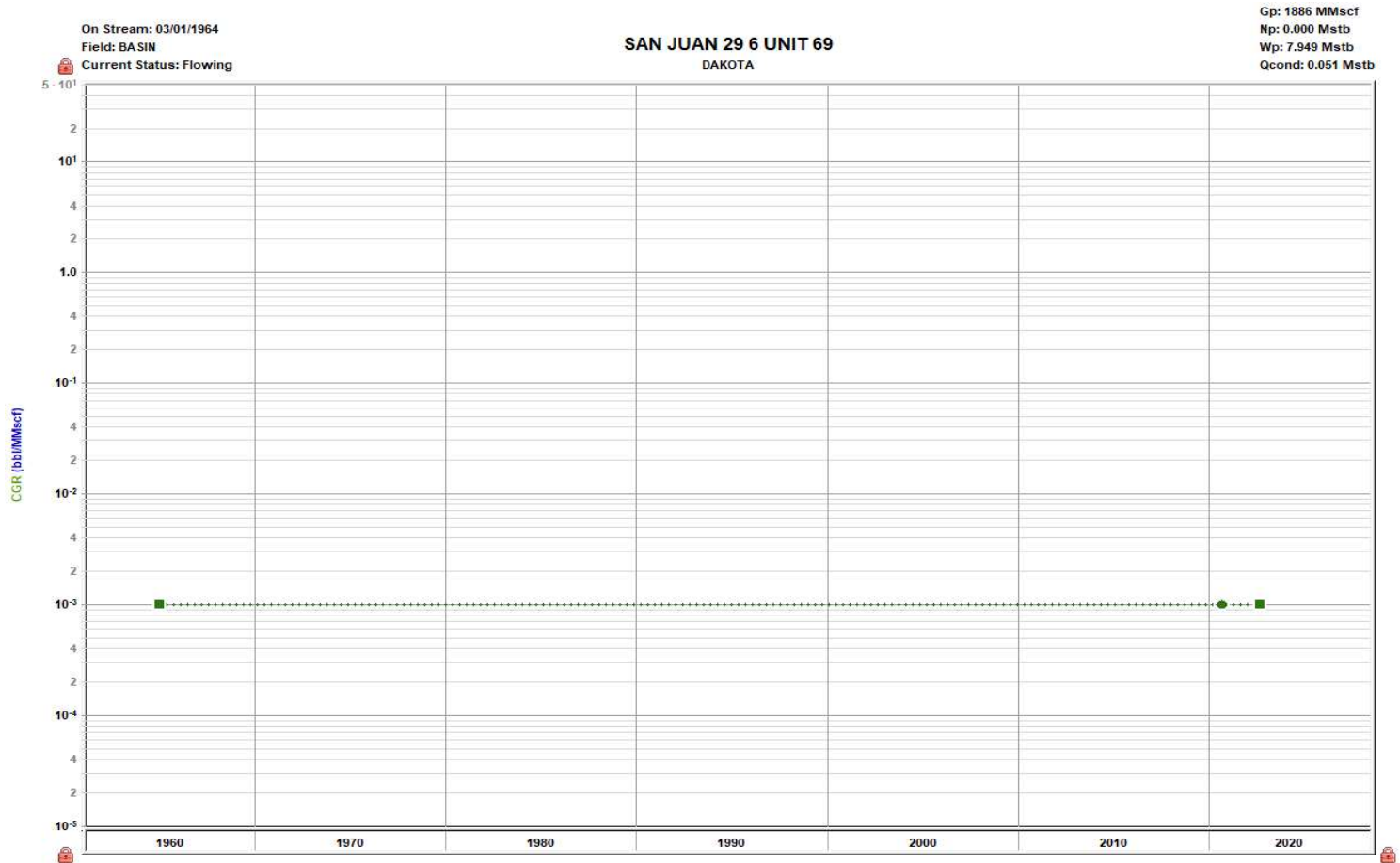
