Isolate the Mesaverde, pump a cement squeeze to achieve sufficient coverage across the FRC and PC, perforate and stimulate the UPE Fruitland Coal and Picture Cliffs in 2-3 stages down the csg. Commingle the Fruitland Coal / Picture Cliffs production with the existing Mesaverde production. Strip facilities if necessary; repair production eqmt as needed, upgrade automation, and install pumping unit.

**JOB PROCEDURES**

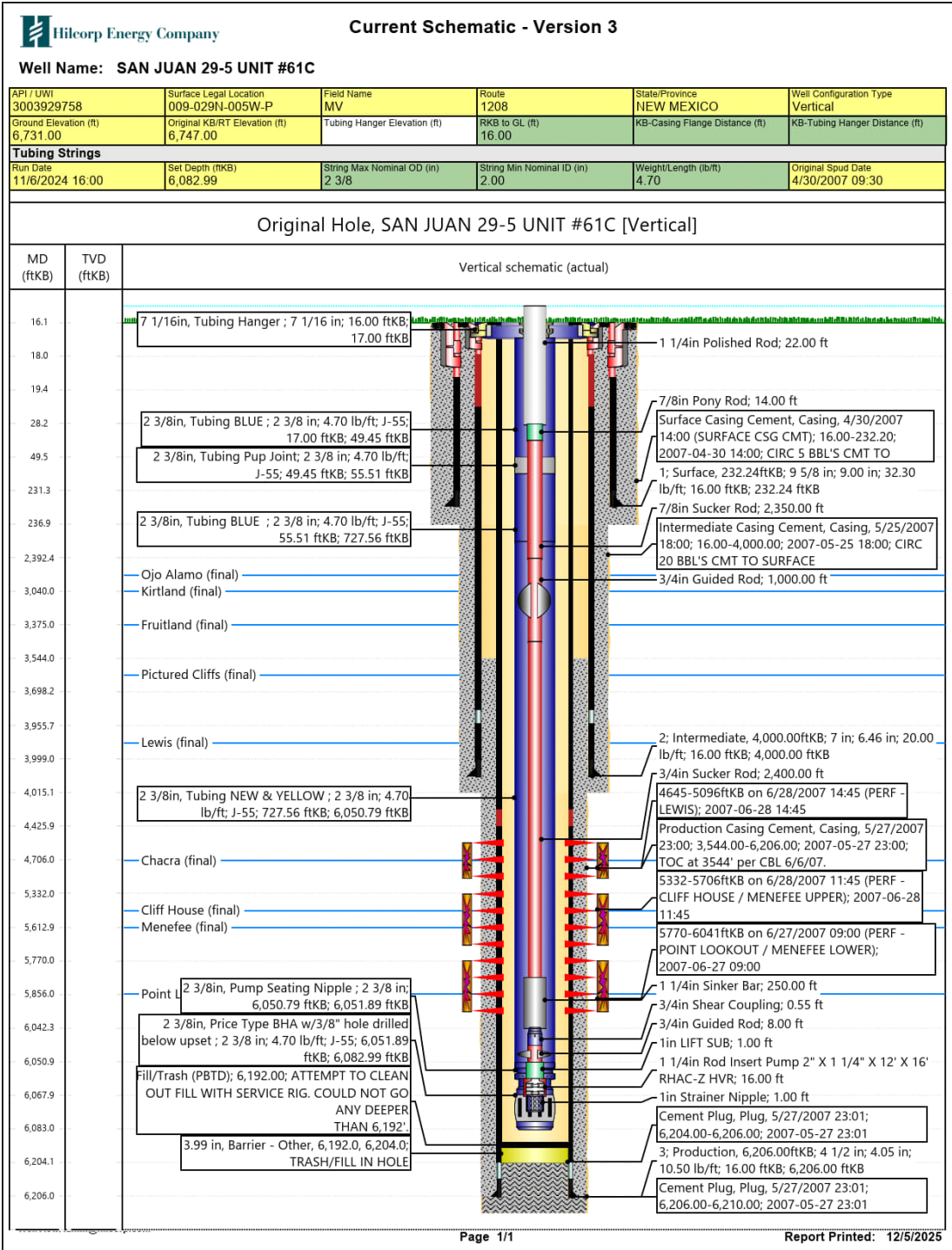
- NMOCD **Contact OCD 24 hrs prior to MIRU. Record and document all casing pressures daily, including BH, IC (if present) and**  
 BLM **PC. Comply with all NMOCD, BLM, and HEC safety and environmental regulations.**

1. MIRU service rig and associated equipment.
2. Nipple down wellhead, nipple up and test BOPs per HEC, State, and Federal guidelines.
3. TOOH with 2-3/8" tubing
4. **Set a 4-1/2" bridge plug at 4,600' to isolate the Mesaverde formation. The BP must be set within 50 ft of the top MV perforation.**
5. RU pressure test truck. Perform a Mechanical Integrity Test on the wellbore above the plug at 4,600'. Chart record the MIT test (notify BLM and NMOCD +24hr before actual test).
6. Perforate for circulating squeeze at **-3,530'**. Establish circulation to surface, circulate a column of cement to adequately cover the Fruitland Coal interval + 150'.  
NOTE: a CBL ran on 06/06/2007 indicates TOC at 3544'
7. Drill out cement. Perform an additional witnessed MIT test on the csg (notify BLM and NMOCD +24hr before actual test). Run an additional CBL to verify TOC.
8. **If frac will be pumped down casing:** ND BOP, NU frac stack and test frac stack and casing to frac pressure.
9. RU E-Line Crew. Perforate the **Fruitland Coal from 3,375' to 3,674'** and **Picture Cliffs from 3,675' to 3,995'**.
10. **If frac will be pumped down a frac string:** RIH w/ frac string and packer. Set packer within 80' of top perforation. ND BOP, NU frac stack. Pressure test frac string and frac stack to frac pressure.
11. RDMO service rig. RU Stimulation crew. Frac the Fruitland Coal and Picture Cliffs in one or more stages. Set plugs in between stages, if necessary
12. MIRU service rig. Nipple down frac stack, nipple up BOP and test. Kill well with fluid, if necessary
13. If frac was performed down frac string: POOH w/ frac string and packer.
14. **Pending C107A approval**, drill out stage plugs and Mesaverde isolation plug. Clean out to PBTD at **6,192'**. TOOH w/cleanout assembly
15. TIH and land 2-3/8" production tubing. Run pump and rods, install pumping unit.
16. **Flowback well thru flowback separator and sand trap. Get a trimmingleed Fruitland Coal / Picture Cliffs / Mesa Verde flow rate.**

**SAN JUAN 29-5 UNIT 61C - CURRENT WELLBORE SCHEMATIC**

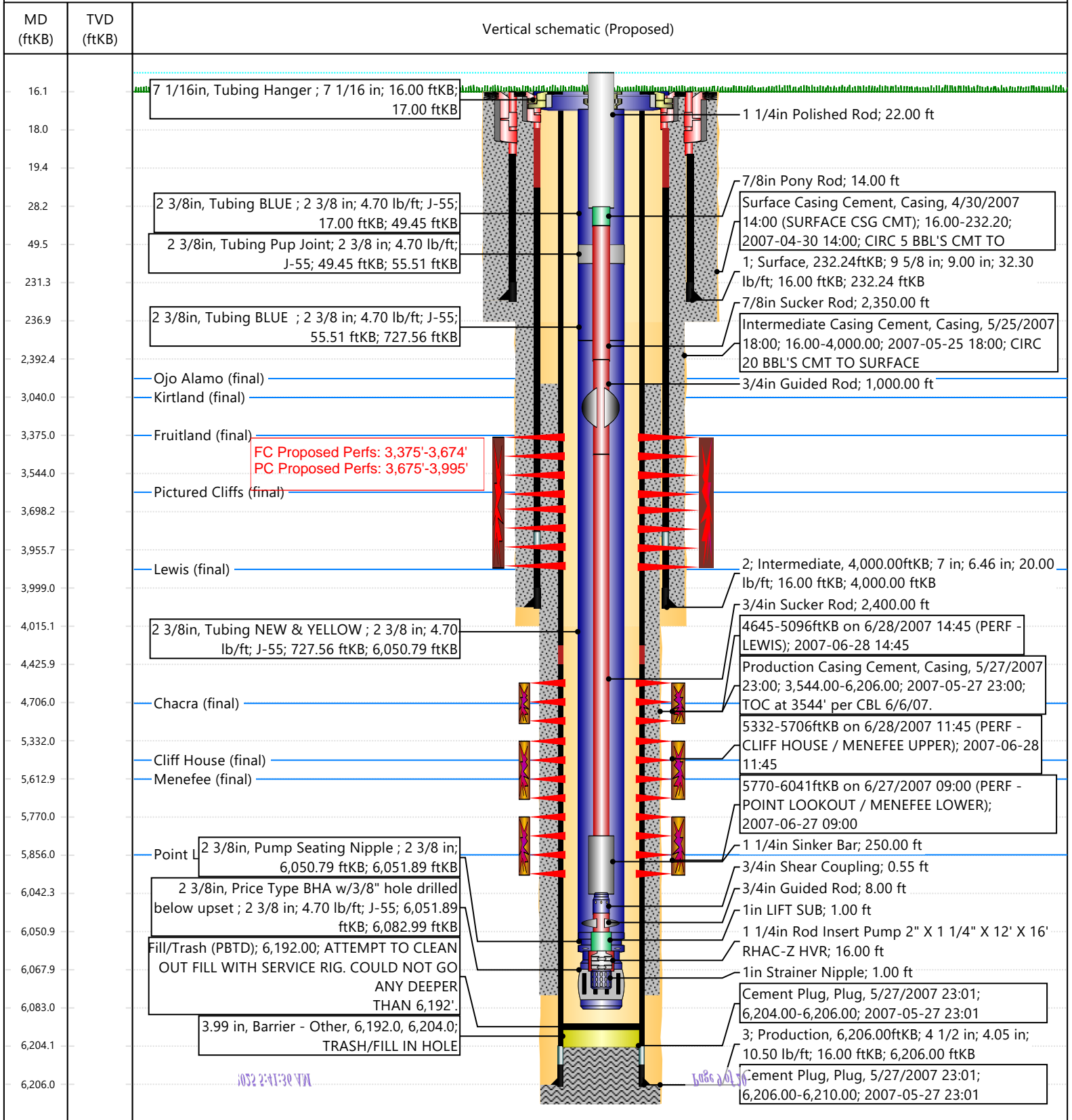

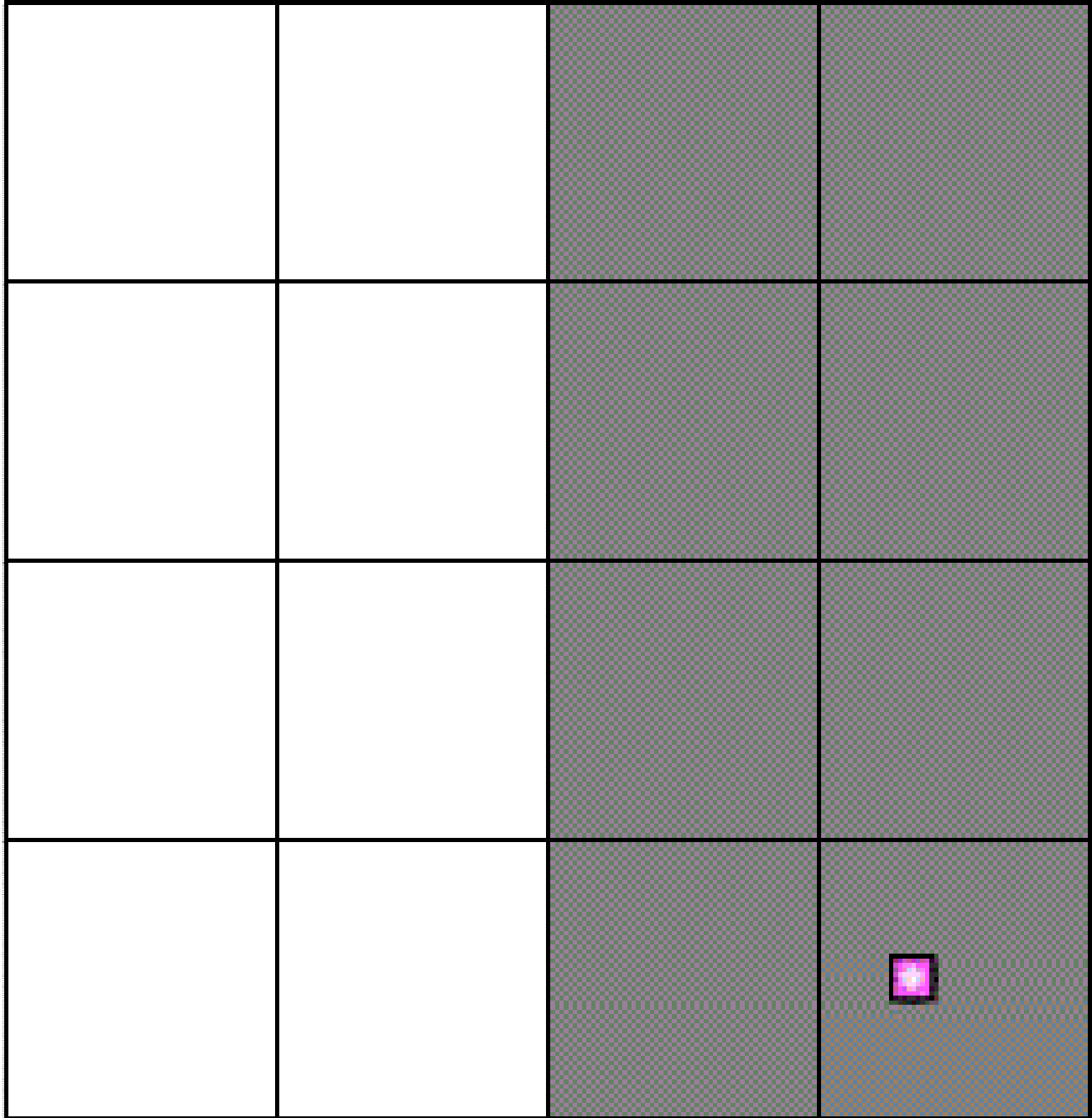

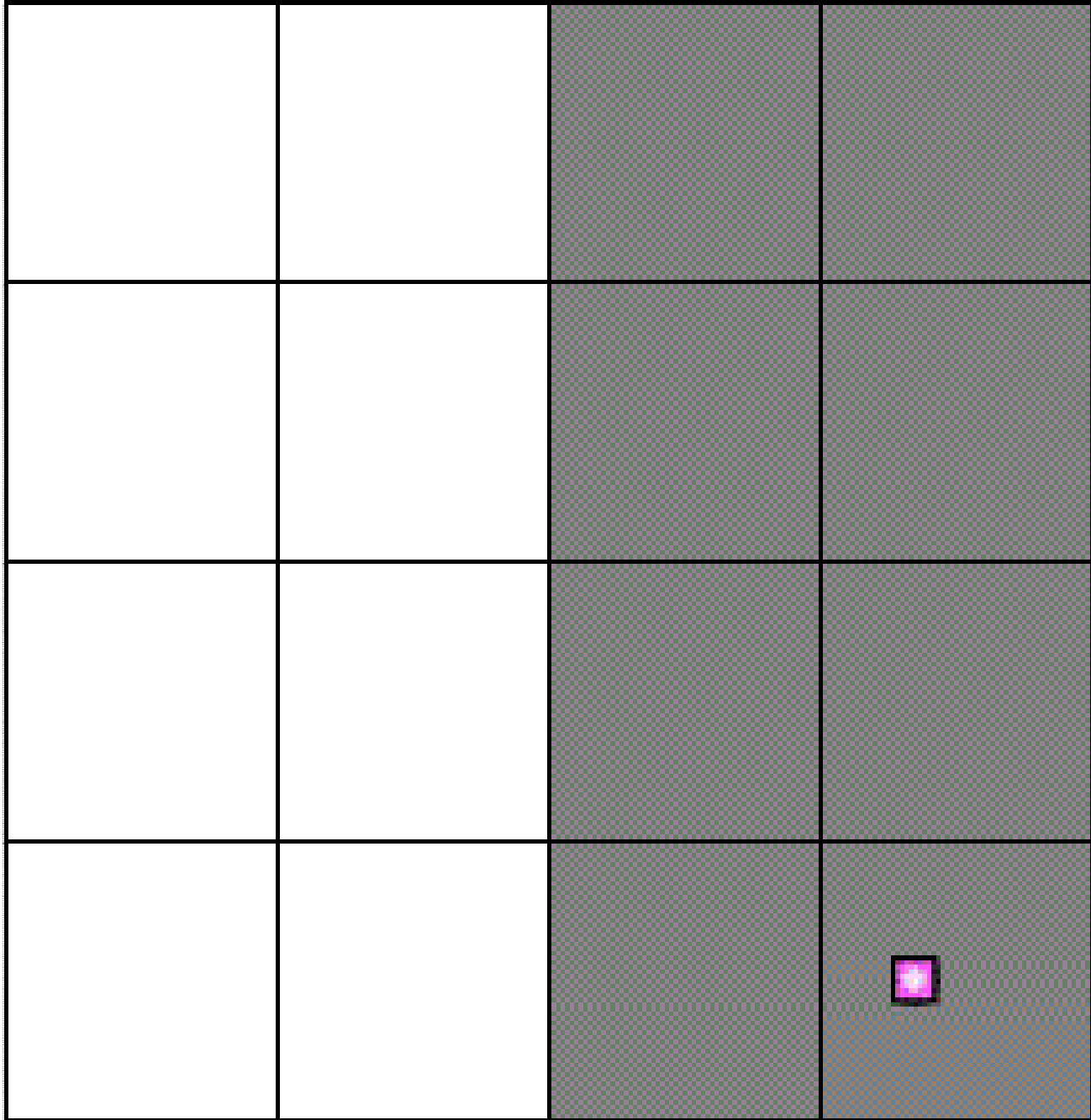

(b) Operator becomes aware that it has, cumulatively for the year, become out of compliance with its baseline natural gas capture rate or natural gas capture requirement, no later than 20 days after becoming aware of such information, Operator shall submit for OCD's approval a new or revised Natural Gas Management Plan for each well it plans to spud during the next 90 days containing the information specified in Paragraph (2) of Subsection D of 19.15.27.9 NMAC, and shall file an update for each Natural Gas Management Plan until Operator is back in compliance with its baseline natural gas capture rate or natural gas capture requirement.

2. OCD may deny or conditionally approve an APD if Operator does not make a certification, fails to submit an adequate venting and flaring plan which includes alternative beneficial uses for the anticipated volume of natural gas produced, or if OCD determines that Operator will not have adequate natural gas takeaway capacity at the time a well will be spud.

## VI. Separation Equipment:

Hilcorp Energy Company (HEC or Operator) production facilities include separation equipment designed to efficiently separate gas from liquid phases to optimize gas capture based on projected and estimated volumes from the targeted pool of our recompleting project. HEC will utilize flowback separation equipment and production separation equipment designed and built to industry specifications after the recompleting to optimize gas capture and send gas to sales or flare based on analytical composition. HEC operates facilities that are typically one-well facilities. Production separation equipment is upgraded prior to well being completed, if determined to be undersized or inadequate. This equipment is already on-site and tied into our sales gas lines prior to the recompleting operations.

## VII. Operational Practices:

1. Subsection (A) Venting and Flaring of Natural Gas
  - o HEC understands the requirements of NMAC 19.15.27.8 which outlines that the venting and flaring of natural gas during drilling, completion or production operations that constitutes waste as defined in 19.15.2 are prohibited.
2. Subsection (B) Venting and Flaring during drilling operations
  - o This gas capture plan isn't for a well being drilled.
3. Subsection (C) Venting and flaring during completion or recompleting
  - o Flowlines will be routed for flowback fluids into a completion or storage tank and if feasible under well conditions, flare rather than vent and commence operation of a separator as soon as it is technically feasible for a separator to function.
  - o At any point in the well life (completion, production, inactive) an audio, visual and olfactory inspection be performed at prescribed intervals (weekly or monthly) pursuant to Subsection D of 19.15.27.8 NMAC, to confirm that all production equipment is operating properly and there are no leaks or releases.
4. Subsection (D) Venting and flaring during production operations
  - o At any point in the well life (completion, production, inactive) an audio, visual and olfactory inspection be performed at prescribed intervals (weekly or monthly) pursuant to Subsection D of 19.15.27.8 NMAC, to confirm that all production equipment is operating properly and there are no leaks or releases.
  - o Monitor manual liquid unloading for wells on-site or in close proximity (<30 minutes' drive time), take reasonable actions to achieve a stabilized rate and pressure at the earliest practical time, and take reasonable actions to minimize venting to the maximum extent practicable.
  - o HEC will not vent or flare except during the approved activities listed in NMAC 19.15.27.8 (D) 1-4.
5. Subsection (E) Performance standards
  - o All tanks and separation equipment are designed for maximum throughput and pressure to minimize waste.
  - o If a flare is utilized during production operations it will have a continuous pilot and is located more than 100 feet from any known well or storage tanks.
  - o At any point in the well life (completion, production, inactive) an audio, visual and olfactory inspection be performed at prescribed intervals (weekly or monthly) pursuant to Subsection D of 19.15.27.8 NMAC, to confirm that all production equipment is operating properly and there are no leaks or releases.

6. Subsection (F) Measurement or estimation of vented and flared natural gas
  - o Measurement equipment is installed to measure the volume of natural gas flared from process piping.
  - o When measurement isn't practicable, estimation of vented and flared natural gas will be completed as noted in 19.15.27.8 (F) 5-6.

VIII. Best Management Practices:

1. Operator has adequate storage and takeaway capacity for wells it chooses to recomplete as the flowlines at the sites are already in place and tied into a gathering system.
2. Operator will flare rather than vent vessel blowdown gas when technically feasible during active and/or planned maintenance to equipment on-site.
3. Operator combusts natural gas that would otherwise be vented or flared, when technically feasible.
4. Operator will shut in wells in the event of a takeaway disruption, emergency situation, or other operations where venting or flaring may occur due to equipment failures.
