- Relatch O/O tool to pkr
- Pressure test the casing to 500 psi, via a state approved MIT.

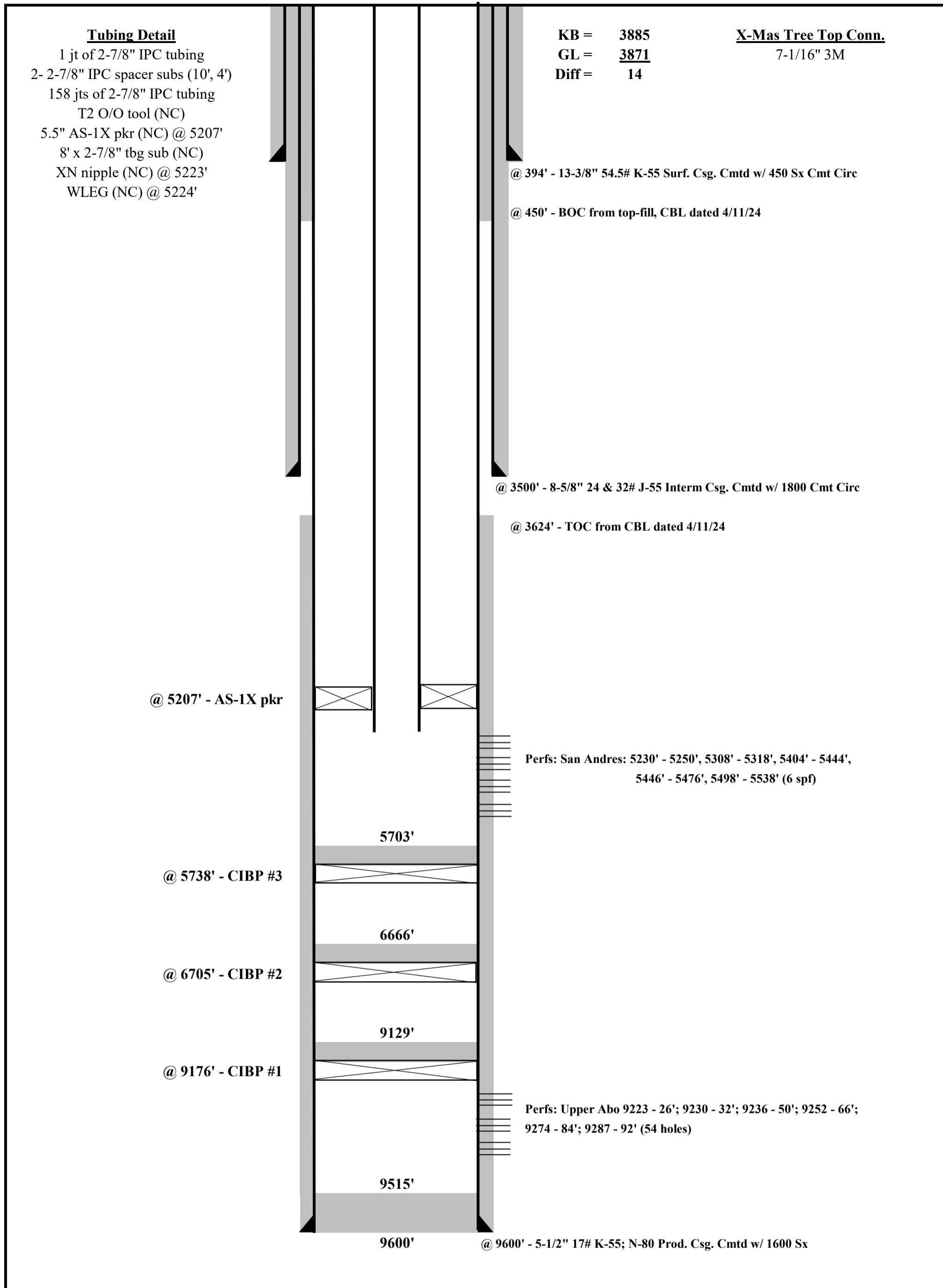

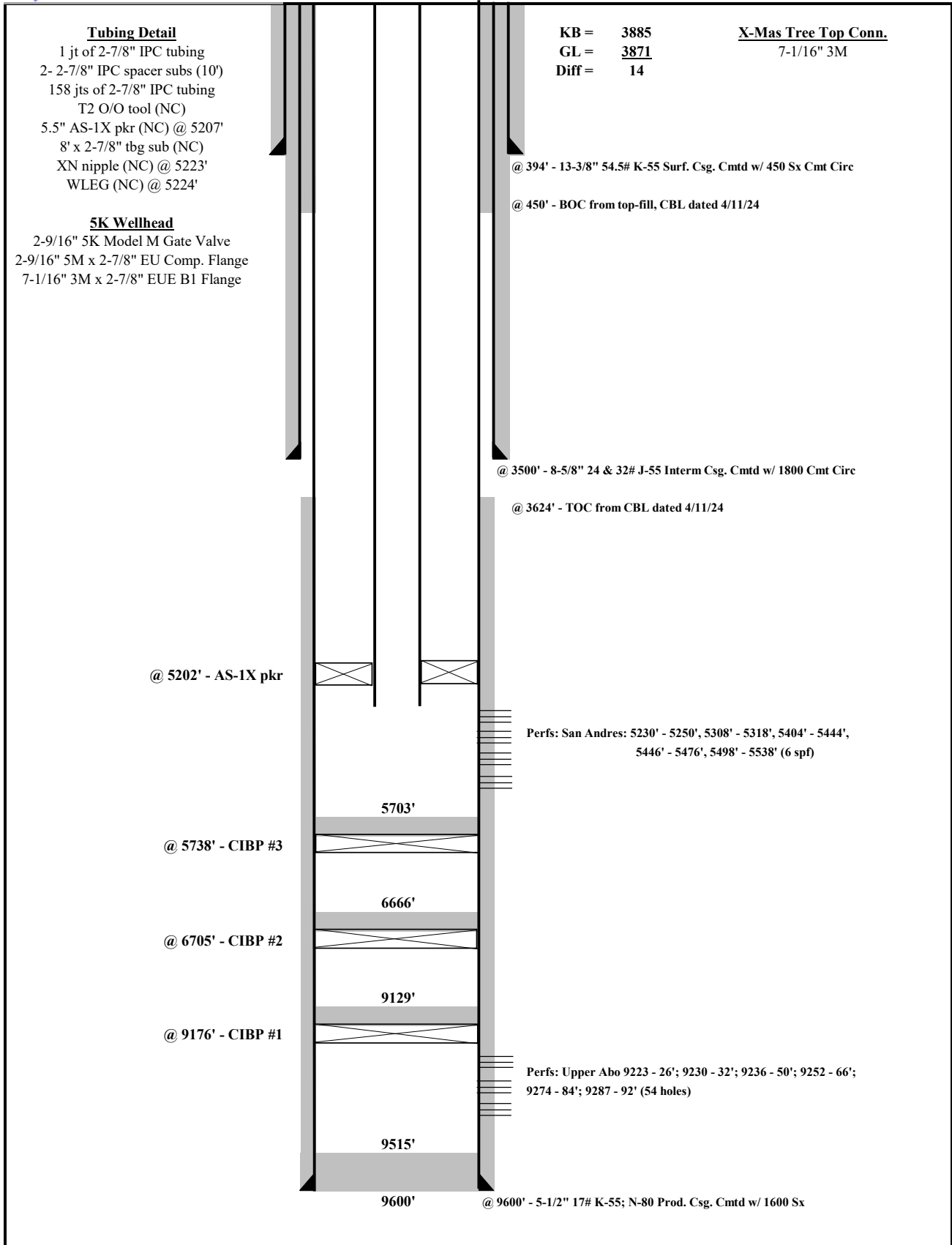

- Latch back onto pkr at same set depth (5,207')
- Unlatch from pkr, and reverse circulate pkr fluid down the csg
- Relatch O/O tool to pkr
- Pressure test the casing to 500 psi, via a state approved MIT.
