04/09/05 Spud @ 12:30 p.m. Drill 11" surface hole to 347'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 347'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 8 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

04/10/05 Drill 7 7/8" hole from 347' - 1,825'. Reached TD 1,825' at 10:00 a.m. MIRU Patterson and log well. Logger's TD at 1,820'. Run 43 jts 5 1/2", 15.5#, J-55 LT & C casing at 1,766'. HES mixed and pumped 252 sks Midcon II cement. Plug down at 2:30 p.m. Circulated 15 bbls cement to surface. Well shut in.
