04/07/05 Spud @ 8:45 a.m. Drill 11" surface hole to 313'. Run 7 jts. of 8 5/8", 24#, J55 ST & C casing at 303'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 5 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

04/08/05 Drill 7 7/8" hole from 313' - 2,035'. Reached TD 2,035' at 6:00 a.m. MIRU Patterson and log well. Logger's TD at 2,016'. Run 48 jts 5 1/2", 15.5#, J-55 LT & C casing at 1,977'. HES mixed and pumped 296 sks Midcon II cement. Plug down at 3:45 p.m. Circulated 6 bbls cement to surface. Well shut in.
