04/28/05 Spud @ 2:30 p.m. Drill 11" surface hole to 343'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 333'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

04/29/05 Drill 7 7/8" hole from 343' - 2,510'. Reached TD 2,510' at 11:00 a.m. MIRU Patterson and log well. Logger's TD at 2,359'. Run 60 jts 5 1/2", 15.5#, J-55 LT & C casing at 2,490'. HES mixed and pumped 375 sks Midcon II cement. Plug down at 5:45 a.m. Did not circulate cement to surface.
