06/17/05 Spud @ 10:15 p.m. Drill 11" surface hole to 345'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 334'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

06/18/05 Drill 7 7/8" hole from 345' - 2,305'. Reached TD 2,305' at 9:45 p.m. MIRU Patterson and log well. Logger's TD at 2,284'. Run 54 jts 5 1/2", 15.5#, J-55 LT & C casing at 2,245'. HES mixed and pumped 400 sks Midcon II cement. Plug down at 9:29 a.m. Circulated 30 bbls cement to surface. Well shut in.
