06/29/05 Spud @ 12:30 p.m. Drill 11" surface hole to 345'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 335'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

06/30/05 Drill 7 7/8" hole from 345' - 2,305'. Reached 2,305' TD at 8:30 a.m. MIRU Patterson and log well. Logger's TD at 2,291'. Run 55 jts 5 1/2", 15.5#, J-55 LT & C casing at 2,267'. Pressured up on casing. Could not circulate or establish any rate. No cement pumped. Shut well in. Wait on squeeze job and completion procedures.
