
This office has taken the necessary action and CA NMNM131621 has been terminated.

Dear Ms. Marquez:

It appears that in November, 2013, BP America Production Company ("BP") submitted a Communitization Agreement ("CA") for the Gooch #2 (MV) well. Upon a closer review of the spacing unit information, this CA was not required. Submitted, was a Blanco Mesaverde – CA for the N/2 of Section 29-T28N-R08W but this was incorrect. The true MV spacing for this well is the E/2 of Section 29-T28N-R08W not the N/2 of said section. The E/2 of this section is covered by a Federal lease being the SF-080112 so a CA was not required for the Gooch #2 – MV well.

With this new information, BP requests CA #NMNM131621 be terminated. For your information and file, I have included the following:

- 2) State of New Mexico Form C-102 Acreage Dedication Plat
- 3) NMOCD letter dated 3/6/2008 approving E/2 acreage dedication for the MV.
