2. Set Whip stock in 5 1/2" casing at 1,813'.
3. Cut window in 5 1/2" casing at 1,807' - 1813'.
4. Drill a 4 3/4" hole in a 130' (42°) Radius curve to a 2,760' horizontal lateral in the lower Vermejo coal (Top 1,943' TVD).
5. Run 3 1/2" liner (No Cement) the length of the lateral.
6. Retrieve whip stock and RBP.
7. Clean out well bore, run production equipment, and put well back on production.
