02/22/06 Spud @ 4:00 p.m. Drill 11" surface hole to 350'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 341'. Halliburton mixed and pumped 100 sk Midcon II cement, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

02/23/06 Drill 7 7/8" hole from 350' - 2,755'. Reached TD 2,755' at 7:00 p.m. MIRU Patterson and log well. Logger's TD at 2,711'. Run 64 jts 5 1/2", 15.5 #, J-55 LT & C casing at 2,585'.

02/24/06 HES mixed and pumped 367 sks Midcon II cement. Circulated 30 bbls of cement to surface.
