ND meter run. MI x RU WL. Tie in to cased-hole logs (by Renegade WL, 8/20/14). RIH x set 5-1/2" AS1X packer x plug at 2090'. RD WL. MI x RU pulling unit. NU BOP. Run 71 jts. 2-7/8" fiberglass tubing x 4' FG sub x 4' chrome sub. Install tubinghead x 2-1/2" master valve. Load backside with 32 bbls packer fluid x test to 500#. RD pulling unit x MI x RU wireline. RIH x latch onto blanking plug. POOH w/plug x RD wireline. Rebuild meter run x turn well over to production.
