From Roy, NM, go east on state highway 120 about 25 miles to mile marker 101, just past the mile marker, turn right onto the caliche county road. There is a large blue and white sign there with the lettering "L-9 Ranch ----->" at that intersection. Go east on the county road for 5 miles, you will come to a 90 degree left turn in the county road. There are several houses at that turn, you go straight through the cattleguard onto a dirt two track road. Follow the road southeast about 0.6 miles, turn right into the well. Cell coverage is spotty in that area.
