03/15/06 Spud @ 10:15 a.m. Drill 11" surface hole to 345'. Run 12 jts. of 8 5/8", 24#, J55 ST & C casing at 337'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

03/16/06 Drill 7 7/8" hole from 345' - 2,185'. Reached TD at 2,185' at 11:15 a.m.. MIRU Patterson and log well. Logger's TD at 2,176'. Run 53 jts 5 1/2", 15.5 #, J-55 LT & C casing at 2,101'. HES mixed and pumped 283 sks Midcon II cement. Circulated 12 bbls of cement to surface.
