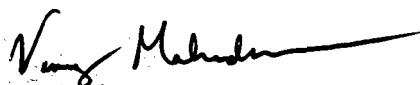
Black River Water Management Company, LLC, OGRID 371287, respectfully requests approval to inject through 5 ½" tubing for the Black River SWD, as it poses no issues of approaching the formation fracture pressure based on the BHP data attached.

The Black River SWD started injecting water at year end 2016 and now has two months of reliable injection data. The well is only able to inject ~21,000 bbls/d which is far below the expected rate. Injection is through 4 ½" internally-coated tubing and at no more than 2740 psi as specified by the above-referenced Administrative Order.

On February 21st, we placed a BHP memory gauge and conducted both a step-rate and injection falloff test confirming the deliverability restriction is due to pressure loss. At the maximum step-rate of 12.05 bbl/min (17,352 bbl/d), there was 1486.4 psi of friction loss, only 253.7 psi above the formation pore pressure to deliver water into the reservoir. The installation of 5 ½" tubing will allow injection to reach a rate of +30,000 bbl/d which is consistent with other commercial SWDs and poses no issue to the reservoir integrity.
