04/09/06 Spud @ 3:45 a.m. Drill 11" surface hole to 330'. Run 9 jts. of 8 5/8", 24#, J55 ST & C casing at 318'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

04/10/06 Drill 7 7/8" hole from 330' - 2,625'. Reached TD at 2,625' at 7:30 a.m. MIRU Patterson and log well. Logger's TD at 2,621'. Run 68 jts 5 1/2", 15.5 #, J-55 LT & C casing at 2,592'. HES mixed and pumped 428 sks Midcon II cement. Circulated 31 bbls of cement to surface.
