03/28/06 Spud @ 3:45 p.m. Drill 11" surface hole to 326'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 316'. Halliburton mixed and pumped 100 sks Midcon II cement, 14 ppg, yield 1.66. Circulate 8 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

03/29/06 Drill 7 7/8" hole from 326' - 2,330'. Reached TD at 2,330' at 7:30 p.m. MIRU Patterson and log well. Logger's TD at 2,320'. Run 75 jts 5 1/2", 15.5 #, J-55 LT & C casing at 2,287'. HES mixed and pumped 302 sks Midcon II cement. Circulated 18 bbls of cement to surface.
