06/04/06 Spud @ 2:30 p.m. Drill 11" surface hole to 338'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 329'. Halliburton mixed and pumped 100 sk Midcon II cement, 14 ppg, yield 1.66. Circulated 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

06/05/06 Drill 7 7/8" hole from 338' - 2,845'. Reached TD 2,845' at 5:30 a.m. MIRU Patterson and log well. Logger's TD at 2,802'. Run 87 jts 5 1/2", 15.5 #, J-55 LT & C casing at 2,702'. HES mixed and pumped 369 sks Midcon II cement. Circulated 16 bbls cement to surface.
