3. Cut window in 5 1/2" casing at 1939' - 1945'.
4. Drill a 4 3/4" hole in a 286' (20°) Radius curve to a 1500' horizontal lateral in the lower Vermejo coal (Top 2231' TVD).
5. Run 3 1/2" liner (No Cement) the length of the lateral.
6. Retrieve whip stock and RBP.
7. Clean out well bore, run production equipment, and put well back on production.
