5. Perforate and stimulate the Vermejo and/or Raton Coals. Clean out well bore and run production equipment.

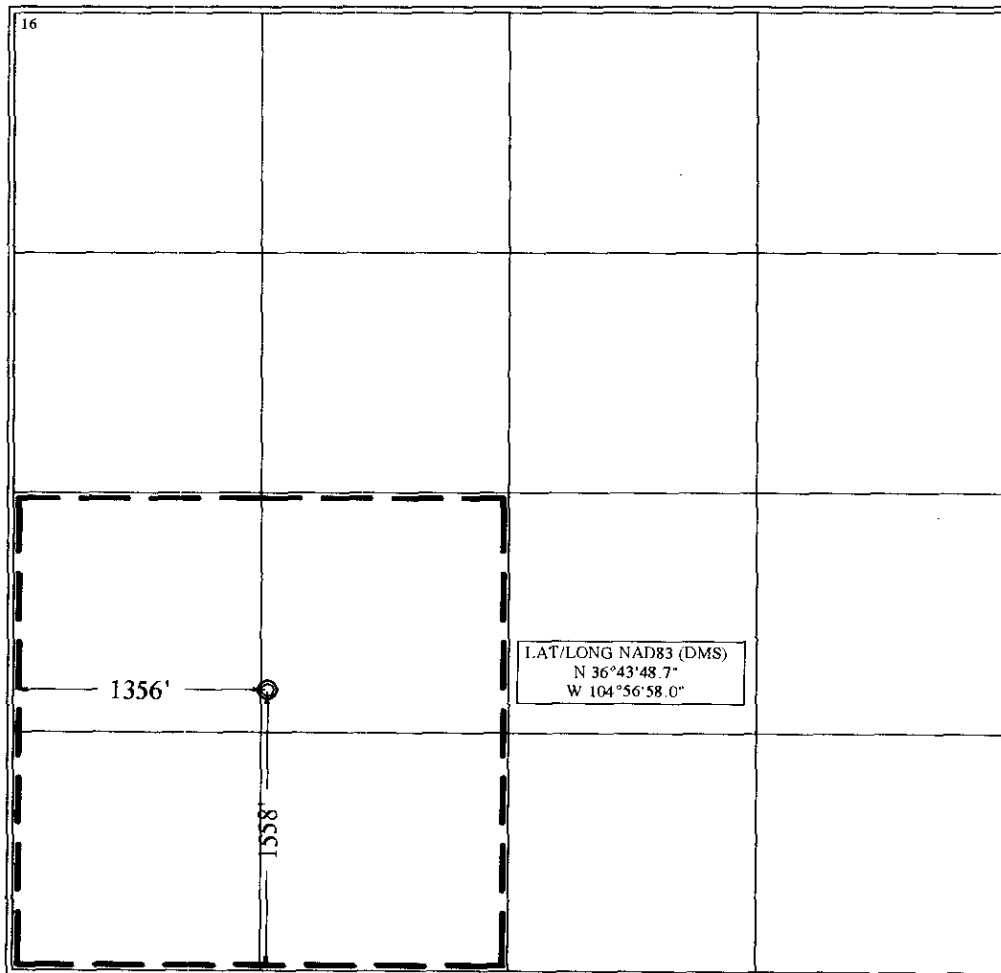
