03/28/07 Spud @ 7:00 a.m. Drill 11" surface hole to 335'. Run 8 jts. of 8 5/8", 24 #, J55 ST & C casing at 323'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 8 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

03/29/07 Drill 7 7/8" hole from 335' - 2695'. Reached TD 2695' at 5:00 p.m. MIRU Superior and log well. Logger's TD at 2663'. Run 56 jts 5 1/2", 15.5 ppf, J-55, and 8 jts 17 ppf, J-55 LT&C casing at 2557'. HES mixed and pumped 299 sks Midcon II cement. Circulated 6 bbls of cement to surface.
