04/17/07 Pense Rig 12 spud @ 5:30 p.m. Drill 11" surface hole to 334'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 323'. Halliburton mixed and pumped 100 sks Midcon II cement. Circulated 5 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

04/18/07 Drill 7 7/8" hole from 323' - 2465'. Reached TD at 2465' at 8:45 p.m. MIRU Superior and log well. Logger's TD at 2276'. Run 51 jts 5 1/2", 15.5 ppf, J-55 and 8 jts 17 ppf, J-55 LT & C casing set at 2330'. HES mixed and pumped 411 sks Midcon II cement. Circulated 22 bbls of cement to surface.
