05/23/07 Drill 7 7/8" hole from 333' - 2305'. Reached TD at 2305' at 9:30 p.m. MIRU Superior and log well. Logger's TD 2255'. Run 48 jts 5 1/2", 15.5 ppf, J-55, and 9 jts 17 ppf, J-55 LT&C casing st 2222". HES mixed and pumped 292 sks Midcon II cement. Circulated 15 bbls of cement to surface.
