07/30/03 Spud in @ 2:45 p.m. Drill 11" surface hole to 350'. Ran 8 jts of 8 5/8", J-55, 24 ppf ST&C casing to 342'. Halliburton mixed and pumped 105 sks Midcon II PP, 14 ppg, yield 1.66 at 3 bpm with 80 psi with 6% salt, .3% gilsonite, .3% versaset, and 25# flocele per sack. Circulated 6 bbls of cement to surface. WOC 8 hrs. Test surface casing to 500 psi for 30 min.

07/31/03 Drill 7 7/8" hole f/ 350' - 2420'. Reached TD at 2420'. MIRU Schlumberger & log well. Ran 12 jts of 5 1/2", J-55, and 44 jts of 5 1/2", M-50, 15.5 ppf LT & C casing to 2377'. Halliburton mixed and pump 40 bbls gel pre flush at 4 bpm at 80 psi, 354 sks Midcon II, 13.0 ppg, yield 2.04, .3% versaset, 5#/sx gilsonite, 2#/sk granulite, 6% salt and .1% Super CBL.

08/01/03 Plug down 3:45 a.m. Circulated 79 bbls of cement to surface. Well shut in.
