03/12/03 Spud @ 11:00 a.m. Drill 11" surface hole to 335'. Run 9 jts. of 8 5/8", J-55, 23 ppf ST&C casing to 327'. Halliburton mixed and pumped 25 bbls water, 100 sx Midcon II, 14 ppg, yield 1.66 at 3 bpm with 25 psi with 6% salt, 5#/sx gilsonite, .3% versaset, 25 #/sk flocele. Circulate 7 bbls of cement to surface. WOC 8 hrs. Test surface casing to 500 psi for 30 minutes. Drill 7 7/8" hole from 335' - 2120'. Reached TD 2120' at 9:30 p.m. MIRU Schlumberger & log well. Loggers TD at 2096'.

03/13/03 Ran 49 jts. of 5 1/2", M-50, 15.5 ppf LT&C casing to 2078'. Halliburton mix and pump 40 bbls water, 20 bbls gel pre flush at 5 bpm with 20 psi, 4 gal LGC, 120# magmafiber, 100# baracarb with 5 bbls water spacer. Pumped 266 sx Midcon II PP, 13 ppg, yield 2.03 at 4 bpm with 15 psi, 6% salt, 2 lb/sx Granulite, 5 lb/sx Gilsonte, .3% Versaset, .1% Super CBL and 25 #/sx flocele. Bump plug with 1619 psi. Check float okay. Circulated 16 bbls of cement to surface. Well shut in.
