08/07/07 Spud @ 2:15 p.m. Drill 11" surface hole to 334'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 323'. Halliburton mixed and pumped 100 sks Midcon II cement. Circulated 5 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

08/08/07 Drill 7 7/8" hole from 334' - 2260'. Reached TD at 2260' at 12:45 a.m. MIRU Superior and log well. Logger's TD 2252'. Run 46 jts 5 1/2, 15.5 ppf, J-55, and 9 jts 17 ppf, J-55 LT&C casing at 2176'. HES mixed and pumped 348 sks Midcon II cement. Did not circulate to pit. Prep for remedial cement squeeze job.
