03/03/08 Spud @ 1:30 p.m. Drill 11" surface hole to 333'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 324'. Halliburton mixed and pumped 100 sks Midcon II cement. Circulated 7 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

03/04/08 Drill 7 7/8" hole from 333' - 2,255'. Reached TD at 2,255' at 3:30 p.m. MIRU Weatherford and log well. Logger's TD 2,227'. Run 0 jts 5 1/2, 15.5 ppf, J-55, and 67 jts 17 ppf, J-55 LT&C casing at 2,101'. HES mixed and pumped 265 sks Midcon II cement. Circulated 12 bbls of cement to surface.
