03/10/08 Spud @ 4:00 a.m. Drill 11" surface hole to 333'. Run 8 jts. of 8 5/8", 24#, J55 ST & C casing at 323'. Halliburton mixed and pumped 100 sks Midcon II cement. Circulated 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

03/11/08 Drill 7 7/8" hole from 333' - 2,245'. Reached TD at 2,245' at 3:30 a.m. MIRU Weatherford and log well. Logger's TD 2,236'. Run 0 jts 5 1/2, 15.5 ppf, J-55, and 53 jts 17 ppf, J-55 LT&C casing at 2,137'. HES mixed and pumped 260 sks Midcon II cement. Circulated 17 bbls of cement to surface.
