13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. This procedure has been reviewed and Ok'd by Mr. Ed Martin of the NMOCD Santa Fe District Office. To plug and abandon this well we plan to do the following steps:


1. MIRU Workover Unit. Strip off Wellhead and place BOP.
2. Pressure test casing and CIBP @ 2000' w/500 psi. CIBP has a 20 cmt cap on top now.
3. PU Workstring & RIH. Tag Plug @ 2000'. Displace Hole w/9.5 #/gal mud.
4. Spot 30 sx cement plug from 1240' to 1350'. This will act as a shoe plug.
5. WOC & Tag Plug.
6. Refill hole w/mud if necessary.
7. Spot 10 sx surface plug from 50' to cutoff point at surface.
8. Weld on Dry Hole marker and restore location.

In attempting to complete this well the Abo zone from 3162 - 3166' was perforated and produced water. A CIBP was set above these perfs. Then the Abo was perforated in the Abo from 2722-2726, 2850-2896, 2961-2962, 3070-3076, & 3116-3117 which produced water. A CIBP was placed over these perfs at 2690'. Then Tubbs was perforated at 2050-2151 with only slight shows of gas on swab. A CIBP and 20' of cement were placed at 2020 to plug this off.



GENERAL INSTRUCTIONS
