Additional Comments: The working pit contents were transferred to the back reserve pint and the deep bury trench was dug in the working pit area. The
deep bury trench was then lined with a 12 mil. liner. All pit contents were then transferred into the lined bury pit and capped
with a 20 mil. liner. Bury pit was backfilled and contoured with 3' of soil capable of supporting native plant growth to prevent
erosion and the ponding of rainwater. No ground water was encountered during this pit closure.
