01/18/04 Spud @ 11:30 p.m. Drill 11" surface hole to 370'. Run 8 jts. of 8 5/8", J-55, 23 ppf ST&C casing to 364'. Halliburton mixed and pumped 35 bbls water, 100 sx Midcon II, 14 ppg, yield 1.66 at 4 bpm with 85 psi with 6 % salt, 5#/sx gilsonite, .3% versaset, .25 #/sk flocele. Circulated 4 bbls of cement to surface. WOC 8 hrs. Test surface casing to 500 psi for 30 minutes.

01/19/04 Drill 7 7/8" hole from 370' - 1525'. Reached TD 1525' at 5:00 p.m. MIRU Schlumberger & log well. Loggers TD at 1485'. Ran 35 jts. of 5 1/2", M-50, 15.5 ppf LT&C casing to 1469'. Halliburton mix and pump 40 bbls water, 40 bbls gel pre flush. Pumped 204 sx Midcon II PP, 13 ppg, yield 2.04 at 4 bpm. with 6 % salt, 2 lb/sx Granulite, 5 lb/sx Gilsomite, .3% Versaset, and .1% Super CBL. Bumped plug with 1300 psi. Float held. Circulated 19 bbls of cement to surface. Well shut in.
