Held safety meetings, Initial report, had extra discussion about backing. MIRU Sundown rig # 201 and associated equipment. Killed well w/ 13 BPW, installed pump in flange and BOP. Pumped another 15 BPW, TIH w/ 2 3/8" sand bailer and 2 3/8" work string off float, had to kill once w/ 13 BPW. Trickled in 7 BPW while TIH. Cleaned out sand to 2990', 81' of sand. TOH laying down work string sand bailer. Secured and closed in. Pumped 60 BPW total. Found 400 psi on well, killed well w/ 17 BPW, removed BOP, RDMO, cleaned location. Turned over to area,

WOS Rigged up on well after frac job, cleaned 81' of sand, returned to production.
