Dear Mr. Stogner:

The referenced well was scheduled to be drilled at an orthodox location of 1900' FSL & 990' FEL in the newly created Shugart; Strawn, North pool. We had to move the well initially 50' west and 80' north to get away from a GPM pipeline and a power line. After BLM inspection we were requested to move the well another 150' west due to a drop off in the sand dunes near by. The Shugart; Strawn, North field rules call for 660' set backs from a quarter section, and no closer than 330' from a quarter/quarter. The final location of Magnum 5 Federal Com 4 of 1980 FSL & 1190 FEL is unorthodox as to distance from the quarter/quarter.

The Well Dedication and Acreage Plat Form C-102 is attached for your reference. Since the well is no closer than 660' to the outer boundary of our lease, and spacing unit, a list of offset operators has not been provided. In view of the multiple moves for safety and drainage purposes, please grant an exception to the location requirements of the Shugart; Strawn, North pool rules, for our Magnum 5 Federal Com # 4 well..
