

Pursuant to our recent telecon, I am notifying you of Echo Production, Inc.'s desire to surface commingle production from the following two State of New Mexico Oil and Gas Leases:

1. New Mexico State Oil and Gas Lease #VO6564 between State of New Mexico and Echo Production, Inc., dated February 1, 2002, located in Lea County, New Mexico and covering the following described lands:

Township 18 South, Range 34 East

Section: 13 - E2NE4

2. New Mexico State Oil and Gas Lease #VO6312 between the State of New Mexico and Echo Production, Inc., dated August 1, 2001, located in Lea County, New Mexico and covering the following described lands:

Township 18 South, Range 35 East

Section: 18 - Lot(s) 1, 2; NE4, E2NW4

The ownership under these two leases is identical in every respect. The common tank battery will be located next to the well located in Township 18 South, Range 34 East, Section: 13 - E2NE4.

Also enclosed is the information that we have sent to the NMOCD. Upon approval from the NMOCD we will of course be requesting a right-of-way permit from your rights-of-way department for the pipeline to the common tank battery. Also, production from the two leases will be allocated by well test.
