Dear Mr. Fesmire:

By Administrative Order NSL-5030 the Oil Conservation Division granted the application of Yates Petroleum Corporation pursuant to the provisions of Division Rule 104 F (2)-(4) adopted on August 12, 1999, for an unorthodox well location for its Agnes "BEB" Com Well No. 1 to be drilled at an unorthodox gas well location 1200 feet from the North line and 1800 feet from the East line (Unit B) of Section 3, Township 18 South, Range 26 East, N.M.P.M., Eddy County, New Mexico. Copies of Yates' application and Administrative Order No. NSL-5030 are attached to this application.

When Yates staked the well it was discovered that the location had to be moved 100 feet to the South and 75 feet to the West to avoid the arch of a pivot irrigation system located in the N/2 of said Section 3. The new location is therefore required by surface conditions as well as the geologic conditions set out in Yates original application. The new location is 1300 feet from the North line and 1875 feet from the East line instead of the previously approved location 1200 feet from the North line and 1800 feet from the East line. Attached to this application as Exhibit A is a plat that shows the location approved by Administrative Order No. NSL-5030 and the amended location required to get outside the arch of the pivot irrigation system.



Yates original application showed the proposed location for the Agnes "BEB" Com Well No. 1 intersects a Morrow sand channel running across the northeast quarter of this section and that to intersect this channel and access these reserves a non-standard location was required. The new location will still enable Yates to access these reserves while avoiding this irrigation system.

This unorthodox location is in the Atoka and Middle Morrow formations and is unorthodox because Rule 2(b) of the Special Rules and Regulations for the Atoka-Penn Gas Pool that provide for "Each well completed or re-completed in this pool to be located in the northwest quarter or southeast quarter of the section and no nearer than 990 feet to the outer boundary of the quarter section nor nearer than 330 feet to any governmental quarter-quarter section line...."

Since this well encroaches only on interior quarter section lines and the mineral interests of all affected persons will be dedicated to the well, there are no affected persons to whom notice of this application is required by Division Rule 1207 (A)(2).

Yates has a contractual obligation to spud this well on or before July 1, 2004 and therefore requests that the Division's action on this application be expedited to the extent possible.
