Sagle and Schwab Energy Resources, agent for SG Interests, I, LTD (SGI) respectively requests administrative approval for a non-standard location for the subject well for topographic reasons.

The well will be completed to the Fruitland Coal Pool. The well is non-standard because it is only 365 feet form the northern boundary of the spacing unit.

SGI originally had the well staked at 670 feet from the North Line and 1770 from the West Line, Section 27, T. 29N., R. 9W., NMPM. This location was rejected by the Bureau of Land Management, Farmington Field Office (BLM/FFO), as it was within the Canyon Largo designated floodplain. In December, 2003 the BLM/FFO signed a Record of Decision (ROD) for future management of federal lands and minerals within the BLM/FFO boundaries. The original staked location was within the delineated 100-year floodplain of Largo Canyon Reach #1, Special Management Area. The management prescriptions for this area state, "Manage existing oil and gas leases under Controlled Surfaced Use constraint in 100-year floodplain." At the request of the BLM/FFO, the new location is staked to be further from Largo Canyon Wash, barely within the Largo Canyon Reach #1 (100-year floodplain). The Largo Canyon Reach #1 occupies the majority of the drilling window. The re-staked location represents the highest elevation area and yet the closest to being a standard location. This new location is acceptable to the BLM/FFO. The well is encroaching on the S/2 of Section 22, T29N., R 9W., as depicted on enclosed Form C-102. The offset operators are listed on the attachment and will be notified by certified letter. Copies of the certified letters are enclosed with this application.

Dear Mr. Garner:

This is in reference to the placement of the proposed Federal 29-9-27 #3, Basin Fruitland coal well, located 365' FNL, 1935' FWL, Sec. 27, T29N, R9W, lease number NMSF-080246. The original proposed well location was at 670' FNL, 1770 FWL, Sec. 27, T29N, R9W.

The Bureau of Land Management (BLM), Farmington Field Office, established the Ephemeral Wash Riparian Area in the 2003 Resource Management Plan (RMP) to protect and promote proper functioning conditions in ephemeral wash systems. Special management constraints and mitigation apply to proposed well locations located in the 100 year floodplains of designated ephemeral wash riparian areas. The proposed Federal 29-9-27 #3 is located in the 100 year floodplain of Canyon Largo. A team of BLM and company personnel conducted a field trip (04/21/04) to find the best possible location for the proposed well. After working to find a suitable location within the windows established by the New Mexico Oil Conservation Commission (NMOCC), we suggest you submit for a non-standard location. A suitable orthodox location was not found because of the proximity of the proposed pad to the Canyon Largo floodplain.

A nonstandard location (365' FNL, 1935' FWL, Sec. 27, T29N, R9W) directly northwest of the existing BP America Florance #124 well pad would be the most suitable. Access to the nonstandard location would be from the northeast corner of the existing location.

In the past, it has been discussed that non-standard locations would probably be proposed more frequently as the more desirable locations are developed. It is our desire to find the best possible locations for new wells and access roads being proposed with minimal environmental impacts. Therefore we will be glad to support your non-standard proposal for the Federal 29-9-27 #3 well to the NMOCC.
