Re: Administrative application (Division reference No. pSEM0-412431231) filed with the Division on April 30, 2004 to "amend" Division Administrative Order NSP-928, which order established a nonstandard 332.64-acre gas spacing unit in the Jalmat Gas Pool (79240) comprising Lots 1 through 4 and the S/2 N/2 (N/2 equivalent) of Section 2, Township 23 South, Range 36 East, NMPM, Lea County, New Mexico, so that this unit will be simultaneously dedicated to Devon's proposed: (i) J. F. Janda (NCT-I) Well No. 11 (API No. 30-025-36396), to be drilled at an unorthodox gas well location 560 feet from the North line and 2310 feet from the East line (Lot 2/Unit B) of Section 2; and (ii) J. F. Janda (NCT-I) Well No. 12 (API No. 30-025-36406), to be drilled at a standard gas well location 1890 feet from the North line and 1650 feet from the East line (Unit F) of Section 2.

Dear Mr. Bruce:

After reviewing the subject application, I find that this non-standard 332.64-acre unit terminated when the last Jalmat gas well on this unit, Chevron U.S.A., Inc.'s J. F. Janda (NCT-I) Well No. 2 (API No. 30-025-09211), located 990 feet from the North and West lines (Lot 4/Unit D) of Section 2, ceased producing in September, 1987. Your application therefore is essentially to restore this 332.64-acre unit for Arch's proposed J. F. Janda (NCT-I) Wells No. 11 and 12. Please reference the attached Memorandum issued by the Division on June 8, 2004 that addresses this matter.

This application is incomplete with respect to notice. Please refer to Rules 4 (A) (2), 4 (C) (1) (a), and 4 (D) of the "Special Pool Rules for the Jalmat Gas Pool," as promulgated by Division Order No. R-8170-P, issued in Case No. 12563 on December 14, 2001 (see copy enclosed).
