- B.) A map shows the proposed location, the respective proration units, and the offsetting proration units (Exhibit B).*



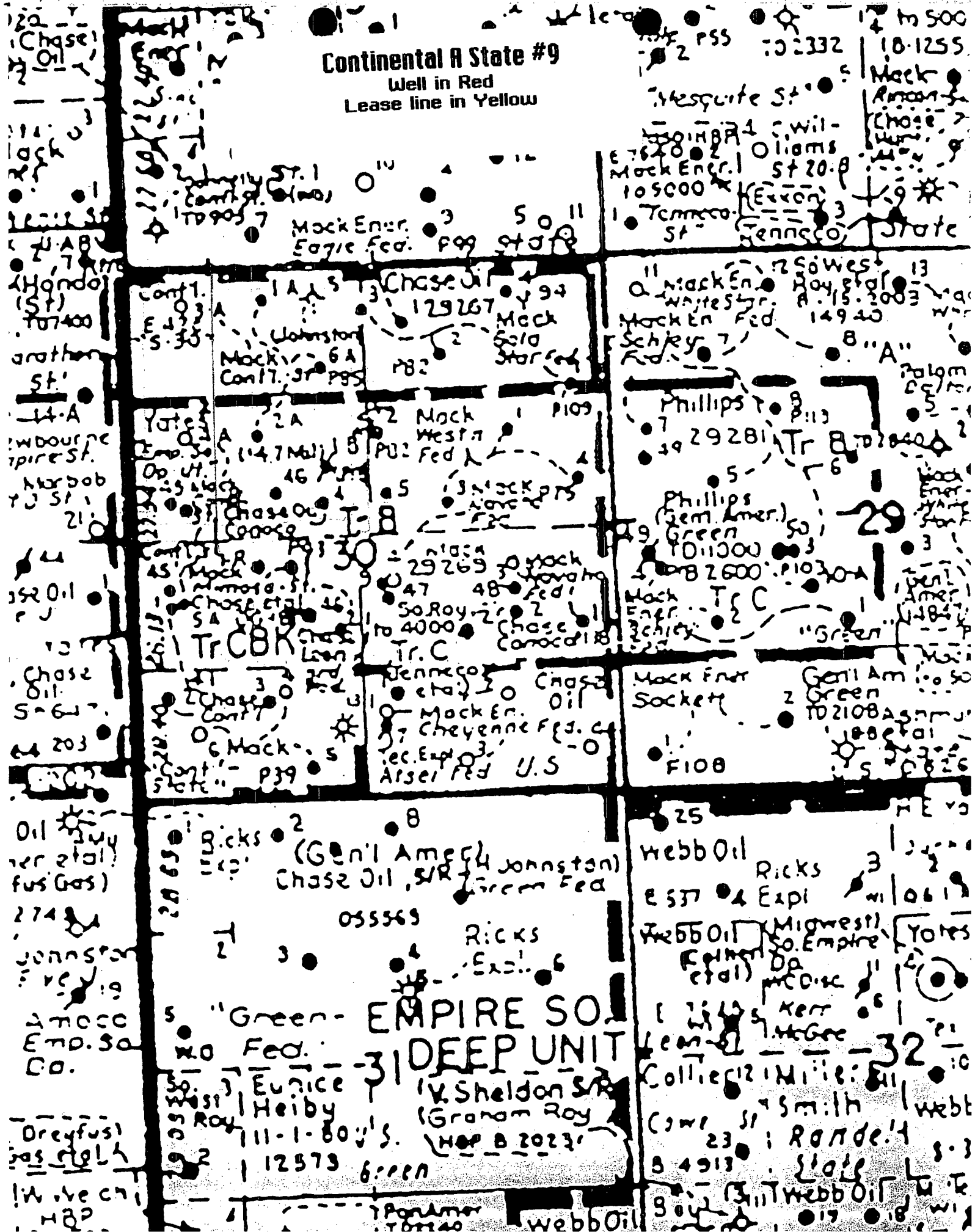
