Pure Resources, L.P. respectfully requests your approval of this administrative application for the subject Unorthodox Oil Well Location. This well will have the SW/4 of NE/4 (40 acres) of Section 9, T-22-S, R-37-E dedicated as its standard oil spacing unit.

We are currently planning to drill and complete the subject Brunson Argo Well No. 29 to a proposed depth of 8,000' or through the Ellenburger zone and complete as an oil well in any one or two of the potentially existing oil pools from the top of the San Andres formation down to TD. Currently we show the potential oil pools as being: Brunson; Ellenburger, Wantz; Abo, Drinkard, Tubb, Paddock and Eunice; San Andres, Southwest. We are purposely not including the Blinebry Oil & Gas (Oil) Pool since our Brunson Argo #10 is already producing from this pool on this 40-acre oil proration unit. In addition, we are not including the Penrose Skelly Grayburg pool since these shallower rights are owned and operated by BEC Corporation on this 40-acre unit.

As indicated by the attached plats, this well's proposed location is Unorthodox in that it is less than the required distance, 330 feet, from the outer boundary of the 40-acre oil proration unit. This location is 170' further South and 45' further east of a standard location and is necessary to allow construction and positioning of the drilling pad and well to avoid several existing pipelines, fences and ROW's in this vicinity.

This resulting Unorthodox Location encroaches upon offset 40-acre oil proration units to the East (or same Brunson Argo lease, operated by ourselves, Pure Resources, L. P.) and to the South and Southeast. In the 40-acre units to the South and Southeast, BEC operates and produces from the Penrose Skelly Grayburg zone (which we do not have the rights to produce from) and Exxon Mobil is currently operating and producing from the Blinebry, Tubb and Abo zones. Both of these two offsetting oil proration units to the South and Southeast have also already been produced from the Paddock, Drinkard and Ellenburger zones. Therefore, we feel that we are not infringing on anyone's correlative rights. This well will also afford us the opportunity to prevent waste by allowing us to produce and capture otherwise un-recoverable reserves without jeopardizing current production in existing wells by attempting to dual complete or commingle downhole in these wells.

A copy of this letter and attachments are being furnished by Certified Mail to offset operators as their notice of this application and to inform them that they have 20 days from receipt of this application by the OCD to submit, in writing, any objections to this application to the OCD in Santa Fe, New Mexico.

Pure Resources, L. P. requests your consideration and approval of this administrative Unorthodox Oil Well Location thus allowing for prevention of waste while protecting correlative rights.
