

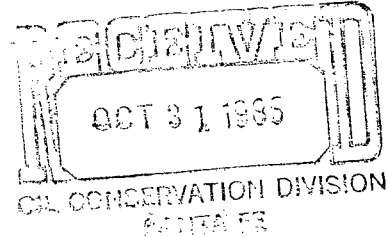

Amoco Production Company requests approval to commingle production from the Otero Chacra and Blanco Mesaverde horizons in the subject well. Commingling is requested for these reasons:

- 1) Producing rates from the Mesaverde are marginally economical.
- 2) If commingled, the Chacra will help produce remaining Mesaverde reserves.

The working interest and royalty of both zones are the same and bottom hole pressure of the Chacra is within 50 percent of the bottom hole pressure of the Mesaverde. Formation fluids are compatible.

In view of Rule 303C, we have attached 2 copies of the following:

1. Acreage Plat indicating ownership of offset leases
2. Well Completion Reports
3. Bottom hole pressures
4. Recommended Allocation Formula
5. Copy of notification to offset operations
6. Form C-116, N.A.
7. Chacra Production Curves

Since the Mesaverde pressures are so low, we are unable to supply production decline curves.

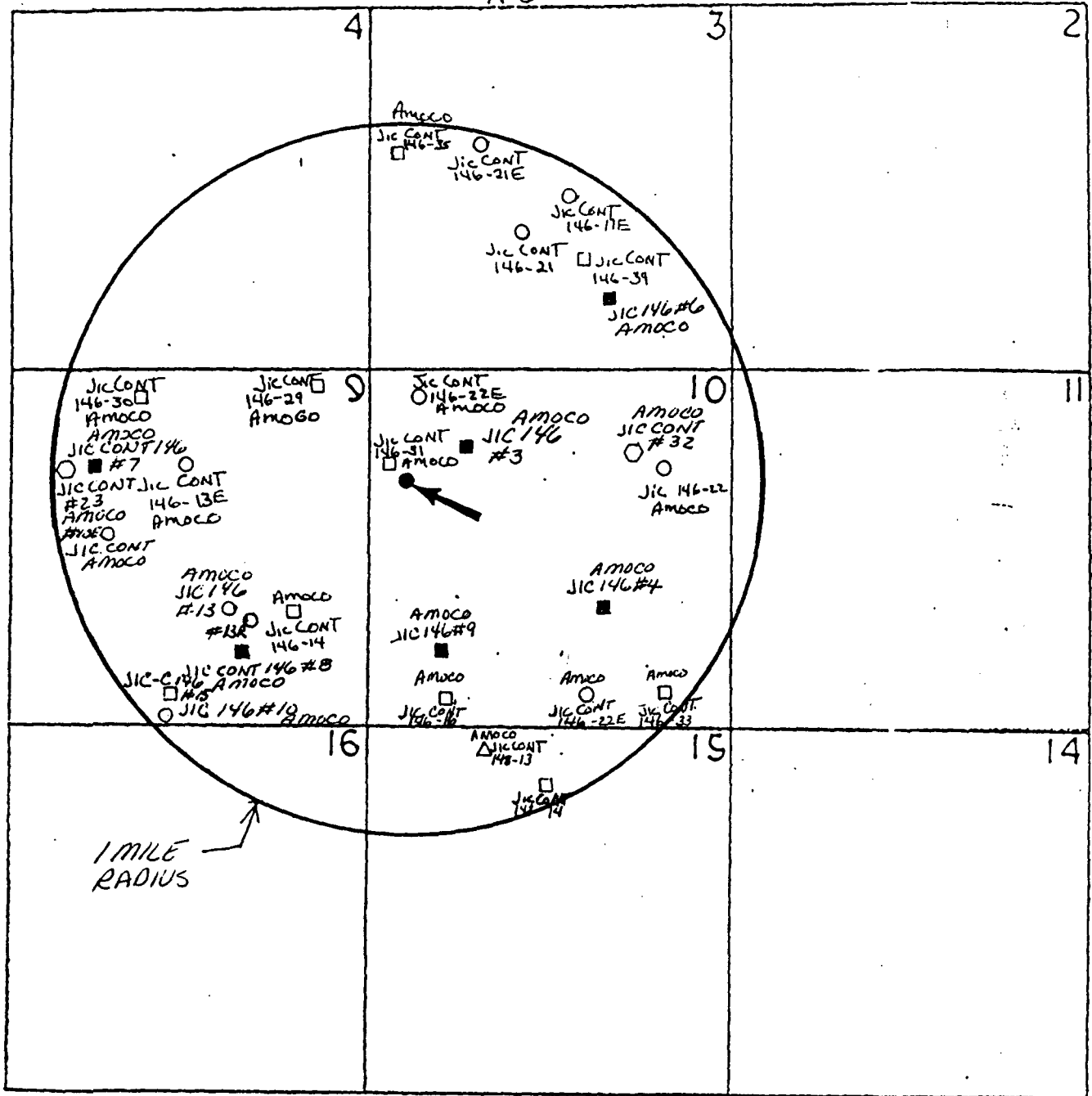

} Tubing pressures are probably low due to high fluid level. They logged off one month prior to the tests.

NOTE: We are unable to obtain bottom hole pressures on these 3 wells due to the wellbore configuration. The small strings of tubing will not allow a pressure bomb to be run inside of them and a fluid level cannot be obtained either. Thus, we have only surface pressures. The tubing pressures are 1" tubing pressures down to the Mesaverde. The casing pressure is actually 2 1/2" tubing down to the Chacra.

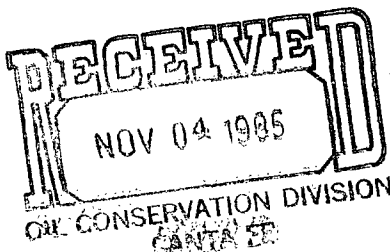
