I visited the site of this well, or very close to it this afternoon. I found a stake with Yates on it, but couldn't read the rest. You have to walk in, there has been no construction that I found. I checked with a brunton compass from another well and it agrees with where I found the stake.

At any rate, this is on top of a narrow ~N-S ridge that is more or less the center of the section. In order to have a standard location, they would have to get into a 300' wide NS strip down in the center of a badlands valley with no roads. I think that topography well justifies this NSL.
