Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed A State No. 48. This well will be drilled as a development oil well in the Artesia Glorieta-Yeso Pool (96830) at an unorthodox oil well location 1000 feet from the North line and 890 feet from the East line (Unit A) of Section 25, Township 17 South, Range 28 East, NMPM, Eddy County, New Mexico.

The proposed A State No. 48 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Artesia Glorieta-Yeso Pool comprising the NE/4 NE/4 of Section 25. This unit is currently dedicated to the proposed Apache A State No. 49 (API No. 30-015-38963) to be drilled 380 feet from the North line and 450 feet from the East line.

The Artesia Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The attached vicinity map shows that the A State No. 48 is to be drilled on the existing well pad for the Lime Rock Resources A, L.P. Marathon "25" State No. 27. The proposed unorthodox is necessary in order to maintain a safe distance from the existing pumping unit for the aforesaid Marathon "25" State No. 27.

The affected offset acreage is the SE/4 NE/4 of Section 25, Township 17 South, Range 28 East. This affected tract is an existing 40-acre spacing unit in the Artesia

Glorieta-Yeso Pool that is operated by Apache. Please note that the working interest ownership between the NE/4 NE/4 of Section 25 and the affected offset 40-acre tract is common. Consequently, notice of this application is not required to any party.

Attached is a Form C-102 and vicinity map.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Artesia Glorieta-Yeso Pool underlying the NE/4 NE/4 of Section 25 that may otherwise not be recovered by the existing or proposed producing wells, thereby preventing waste, and will not violate correlative rights.

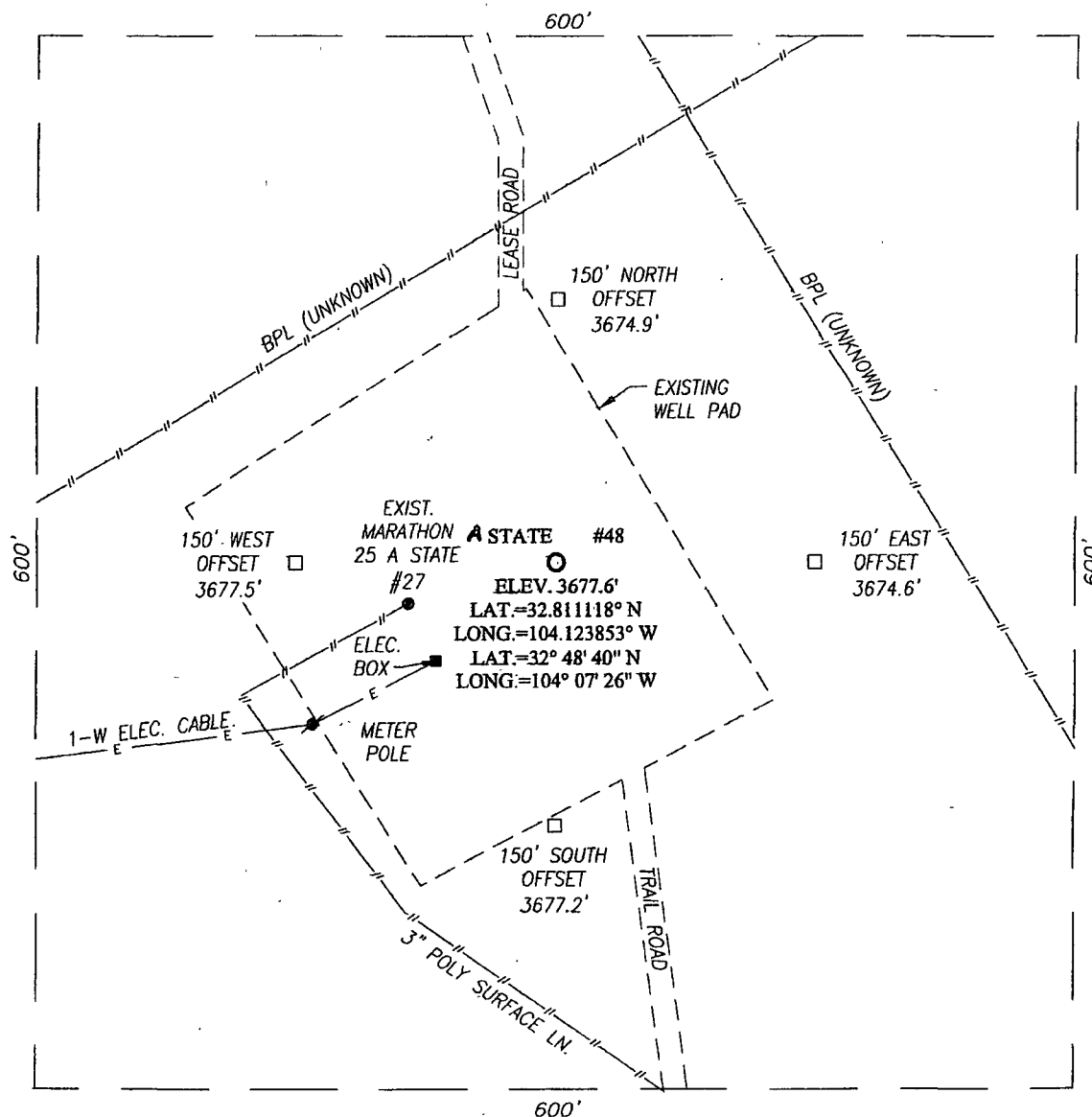

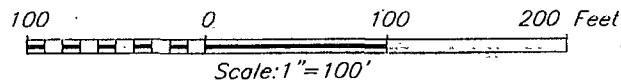
