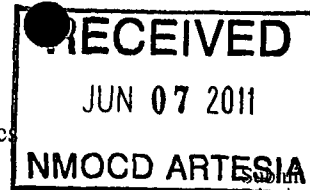

Describe Cause of Problem and Remedial Action Taken. (If water spilled, give Chloride content)*
The W-13 pipeline developed a leak at the coordinates listed above. The pipeline was isolated to prevent additional leakage to the environment and a crew was dispatched to begin the process of making repairs. The pipeline will be repaired by digging up the affected area and applying a clamp to seal the hole. Any contaminated soil will be removed and disposed in an approved OCD landfill. Once the contamination has been removed, the affected area will be backfilled with material indigenous to the area.

Describe Area Affected, Dimensions, and Cleanup Action Taken.*
Affected area consisted of mostly over spray with some liquid that followed cow trails for several feet. Overall demensions of the spill area is approximately 75 feet by 150 feet.
